We work with and survey our suppliers to understand the usage of certified palm oil in our products. A small number of suppliers were not able to provide the specific data needed in the timeframe required for this submission, but we believe this report captures the vast majority of our palm oil usage. RSPO credits are classified as RSPO Credits from Mill/Crusher, in this submission, per the guidance we received from RSPO.
