Sammontana is the first group in Italy in the category of frozen pastry. The frozen pastry production is made in two of its three factories: in Vinci (FI) and Colognola ai Colli (VR). The bakery products, under the brand 'Il Pasticcere', 'Tre Marie' and 'Mongelo' and the Private Labels brands, are represented by croissants and puff pastry, both sweet and salty. These products must be cooked before consumption. The assortment is complemented by a number of other frozen products, produced by co-packers, such as pretzels, bread and sandwiches, various types of pizzas, assorted cakes, precooked frozen products, ready meals and other frozen products that are marketed under the brand 'Il Pasticcere', 'Tre Marie', 'Mongelo' and 'Bonchef'. The products are distributed to shops, bars, bakeries, supermarkets and hotels and directly to consumers. In accordance with this policy Sammontana considers palm oil as one of the possible oils to be used in its bakery production chain, provided that it is cultivated with respect for the environment.
