Our overall traded volume of Palm and Palm Kernel Oils has decreased year on year due to economic conditions and competitor activity. However, within our total volume non-certified quantities have remained broadly similar and therefore represent a higher percentage of total uptake. We continue to work with customers and industry bodies/trade associations to increase awareness of the benefits of using only RSPO certified material. The premium which certification attracts remains the key barrier to change for some sectors of our business.
