In 2022 we continued to make progress increasing the proportion of oils used in our food products that were RSPO segregated as part of our ambition that all oils used in our food and drinks products are segregated - from 67% in 2020, to 85% in 2021, to 94.6% in 2022.

We have not yet achieved 100% segregated oil use in our food and drink products from 2022 and mass balance certified concessions continue to remain important to continuity of business.

We continue to work closely with product suppliers in our non-food categories to ensure the use of certified oils and related products.
