We have been actively working with our supply base to influence uptake of fully segregated derivatives including the development of specific ingredients which has enabled us to achieve fully segregated status in 2021. Since achieving this position, there have been several challenges in the supply of palm oil, as such we have had to make a conscious decision to take mass balance where fully segregated is unavailable. A broader challenge is consumer knowledge and understanding of sustainability, with many not appreciating RSPO and segregated supply chains to be sustainable.
