Woolworths started its sustainable palm oil journey in 2011, when it became the first South African retailer to become a member of the RSPO. Since then, we have been working to transform the local supply chain, including facilitating the training of accredited auditors and working with local refiners to import RSPO palm oil on behalf of our suppliers.
