- 1. To encourage our suppliers to embark on the RSPO journey, we have incorporated RSPO information in our supplier engagements. We have established several initiatives under our Anchor Programmes including Priority Suppliers Engagement Programme (PSEP), which is designed to assess our suppliers' level of compliance with Apical, Apical's Sustainability Policy, Apical's Human Rights Policy and other relevant industry requirements, e.g. RSPO. Our Shared Value Programme (SVP) provides capacity building to suppliers on a wide range of topics that take into account regional issues specific to the location of suppliers as well as the latest local and global market trends and regulations. We also underscore the benefits of international certification schemes, e.g. RSPO and update our suppliers on the latest environmental legislation.
- 2. Apical recognises the challenges independent smallholders face to increase their productivity and meeting stringent sustainability standards. In 2020, we launched the SMILE programme, where we help independent smallholders to through customised seminars and workshops, to educate farmers on yield improvement, sustainable farm management, NDPE, support smallholders to obtain RSPO certification by 2030 and provide training on robust safety measures. SMILE is a tripartite partnership between Apical, Kao and Asian Agri. As at Dec 2023, we have engaged 3,083 smallholders and 839 independent smallholders has been certified.
- 3. We have also launched the Sustainable Living Village (SLV) programme in January 2023 where we enhance livelihoods by nurturing communities. Under the SLV, we target to certify 1000 independent smallholders.
- 4. We will continue to have more dialogues with our buyers on sustainable products including RSPO that we are able to produce and offer by committing to sustainable palm oil production.
