We used RSPO credits to cover 44 tons of palm oil and 27 tons of palm kernel oil, in total 71 tons oil to be used as ingredients. This is equivalent to about 0,2 % of our total use of palm oil products in Arla Foods Amba.

It remains to be a challenge to find segregated certified palm oil products in the Middle East

We have also used 34486 tons of RSPO palm oil credits and 1645 tons of palm kernel expeller credits for palm used in animal feed. This normally are/should be covered by feed companies. It is even a bigger challenge to find segregated certified ingredients for animal feed. It is the second time we register RSPO credits bought to cover palm use in the animal feed. Please keep in mind this is an additional effort to support sustainable palm oil production. And it is not possible to register it separately and therefore mentioned here.
