

99.67% of the palm oil in our own brand products is sourced using physical certified supply chains. The remaining 0.33% consists of a combination of credits to support the production of sustainable palm oil and the fact that the final manufacturer is not supply chain certified themselves and so, even though the palm oil comes from a sustainable source, the chain of custody cannot be passed on. Bidfood is working with these suppliers to gain RSPO supply chain certification.

Some suppliers have commercial and availability challenges when considering RSPO supply chain certification.

Although the palm used in our own brand products is from physical supply chain options, some of our end manufacturers are not supply chain certified and therefore the chain of custody cannot be passed on. Bidfood can only claim 99.67% of the palm is from physical certified supply chains. Some suppliers have commercial and availability challenges when considering RSPO supply chain certification.
