The overall economic state, especially in Germany, has led to a stagnation, if not decrease, of the demand for palm stearin based oleochemicals. The increase in price-sensitivity, that became already visible in previous years, has continued and thus, has put pressure on the RSPO volumes in particular. Furthermore, the favorable trend of prices of non-palm stearin based fatty acid sources has added to their competitiveness.
