The 2023 volumes have significantly decreased vs 2022 (-14%) which is partly explained by a decrease in manufactured products sold (-10%). The remaining percentage might come from a different product mix (volume decrease in products with more palm oil).

We have increased our certified palm oil volumes slower than expected because the remaining volumes come from palm oil contained in other ingredients that are not available with RSPO certification in our current supplier or require R&D work to be substitute with RSPO certified ingredients.
