We, BÄKO Mitteldeutschland eG (headquarters in St. Egidien and second headquarters in Krostitz), are supplied by various suppliers with products that sometimes contain certified and conventional palm oil. The delivered products are resold to our customers without physical possession. Due to the fact that we are a wholesaler of more than 10.000 products (mainly baking agents, oils and fats as well as frozen end products), which almost always contain a small percentage of palm oil (conventional or certified MB/ SG), it is for us very difficult to determine the total amount of certified and non-certified palm oil. Especially since we do not always receive the necessary Information (for points 2.2.; 2.3 and 2.4. and percentages) from the supplier/ manufacturer based on the secret of the recipes.
