Our sales of RSPO MB certified oleochemical and surfactant products have significantly increased in 2023 compared to previous year due to successful sales to a few large multinational consumer companies that are now using more RSPO MB grade product.

This is a growing pattern among large consumer products companies. They are increasing the demand for RSPO MB certified raw material. However, our uptake volumes (sold) is highly dependent on whether we are successful to get the businesses again in 2024, under a highly competitive supply environment.
