In comparison with our ACOP 2021 report (last reporting), we have slightly increased our products uptake from 73,05% to 73,92% in 2023.

Despite the reduction of total consumption, the volume of certified palm oil has remained stable with a slight increase in % of segregated volumes compared to mass balance.
