Certification bodies not aligned on RSPO P&C and SCC Guidelines. Thus, causing suspension of Ciranda's upstream partner's RSPO certifications which further caused disruption to the RSPO IP supply chain. Agropalma had worked to correct non-conformances issued by QIMAIBD. After completion and acceptance of corrective actions they were informed by QIMAIBD that IBD would no longer support RSPO certification. Agropalma then had to contact SCS Global. SCS's interpretation of RSPO guidelines heavily differed from QIMAIBD which is now causing product shortage and major RSPO IP supply issues due to them issuing a suspension of Agropalma's RSPO P&C certification.

Ciranda wishes to promote organic RSPO IP palm fruit and palm kernel oil, but we are unable to do so at this time due to issues previously stated.
