The sale of certified palm oil, palm kernel oil and related products is driven by our customers' demand for RSPO products. Overall there was a decrease in volumes of uncertified and certified palm oil, palm kernel oil, and related products sourced in 2023 compared to 2022, due to changing customer demands. However, there was an broad increase in volumes of RSPO certified palm oil/certified palm kernel oil that was Mass Balance in 2023 compared to 2022. This is even with the moderate decrease in combined total volume of certified and uncertified products sourced, and is likely contributable to an increased demand for more sustainable products containing palm oil/palm kernel oil by our customer base.
