Company will continue to support customers and brands in making products with sustainable palm and encourage RSPO labelling. Presently 120 products manufactured carry RSPO Mixed logo.

The company is actively involved with the Oleochemical group of EFECA and has helped to educate the cosmetics industry regarding palm derivatives and the complexity of manufacturing them.
