We are still working towards achieving a balance between RSPO certified material and cost while considering the 1,4-Dioxane content in the raw material. Because New York State has implemented a 1 PPM limitation on the quantity in finished goods, we have to be considerate of how the raw material is manufactured which limits our raw material selection. We are seeing improvements in this sector, and believe we may be able to accelerate the timeline and obtain a reliable supply of 5 PPM max 1,4-Dioxane SLES that's RSPO certified by the end of this year.
