

To be in accordance with our product specifications, suppliers are obligated to exclusively use sustainable palm oil for EDEKAs own brand products. EDEKA's aim is to achieve as soon as possible 100% segregated supply chains for palm oil in our private label products. Furthermore, EDEKA is a full member of the German Forum for Sustainable Palm Oil (FONAP). Within the FONAP we are engaged in different working groups to develope feasible goals for a more sustainable Palm oil production and a holisitc transformation of the sector. Among others, this includes compliance with an ambitious voluntary commitment including additional requirements for sustainable sourcing, which

- are as follows:
- No illegal FFBs
- Disclosure of GHG gas emissions
- No peat-land and HCV land-use change
- No use of critical pesticides e.g. WHO class 1 a & b
- Mitigation of negative impacts of palm oil cultivation on biodiversity
- Supporting and integrating Smallholders into global supply Chains
- Human rights duty of care

Furthermore we support the FONAP smallholder Project in Indonesia which includes support of women, river protection, reforestation and the use of regenerative agriculture methods.

In addition to that EDEKA is committed to achieve deforestation and conversion-free supply chains for several critical raw materials, including palm oil. In order to reach this ambitious goal EDEKA is oriented on the Accountability Framework Initiative and is formulating a company strategy.
