Additionally, we are seeking assistance from the Roundtable on Sustainable Palm Oil (RSPO) authorities to explore better business opportunities and establish links to kickstart our certified palm oil business journey.

The demand for certified palm oil and related products in the Indian market might not have been as anticipated or might have fluctuated unexpectedly, impacting the readiness of potential buyers to engage in business transactions.
