We purchased a greater percentage of certified palm oil and palm kernel oil products because there was an increase in demand for more certified products for some markets. However this was not the case for other markets where we saw a decline in demand for certified PO and PKO derivatives due to higher than expected stock being in the supply chains. This excess stock has now been cleared and we expect demand to return to previous levels or slightly higher in the future.
