The non-RSPO volumes are linked to our use of RSPO credits to bridge the gaps in certified consumption.

In 2023, we are carrying forward the updates made to our Palm Product Standard in 2022. This has reinforced our plan of driving for 100% RSPO-certified segregated palm as a basic requirement. To accomplish this, we persist in identifying and scrutinizing any circumstances where supply does not meet the new standard. Any exceptions to the standard necessitate approval from our palm governance group and must come with a transition plan. We are continuing to embed knowledge and understanding of the actions necessary to meet our Palm Product Standard, through training sessions with relevant teams, such as Procurement.
