In our plant we produce solid soap bars and we pack liquid cosmetics mixed by third part companies on formulas developed by GFL. Until 2021 we managed certified palm oil/kernel oil only on soap bars and the data on our ACOP were only limited to the palm oil/kernel oil contained in our soap bars. In 2022 we started managing certified palm oil/kernel oil also in our liquid formulas: the numers showed in the current ACOP take into account also the derivatives and fractions used in our liquid formulas (shampoo, body wash, liquid soap, conditioner, body lotion).

The product we produced are basically:

- private label for cosmetic or GDO companies (they have started requesting RSPO palm oil in their products)
- own brand and labelled products for hotel (very price sensitive market and with low request of RSPO certified products)
