Interchem imported and supplied 67.41% more palm derived products compared to the previous year (2022). Additionally there is a 19.84% increase in the RSPO MB Palm Oil products imported in 2023 versus the previous year from 28.08% in 2022 to 47.92% in 2023. This is due to a major customer switching from animal based products to RSPO MB based products.

A proportion of our market consists of technical grade manufacturers who are currently not prepared to pay the premium price for RSPO certified palm oil derivatives. They do not have current drive from their customers to use RSPO certified products. Additionally if there is increased stock availability with competitive pricing, more customers will consider changing over from conventional derivatives to RSPO certified derivatives. Premium price of RSPO certified product is part of a deterrent for customers in order to keep their prices down. Additionally some customers have also shifted their interest to non-palm based derivatives, such as coconut.
