If possible, some customers would prefer to steer away from palm altogether. A viable alternative is coconut oil, however, this is much more expensive. If it were cheaper, soap, as a whole, could be made from this raw material, removing the need for palm kernel and oil.

Alternatively, use of tallow instead of palm oil blended with a smaller percentage of palm kernel oil. Tallow is a by-product of the meat industry and is also readily available, so a great alternative to palm oil.
