Kensing, a company committed to responsible sourcing, has made significant strides in increasing its use of certified palm oil and palm kernel oil. In 2023, Kensing achieved a certified uptake of 40.17%. Looking ahead, they have set ambitious targets: 75% uptake in 2023 and a 100% uptake by 2025. Insufficient demand for RSPO-certified palm oil products and market shortages of certified products continue to present challenges to achieving 100% uptake. Kensing promotes RSPO CSPO in our engagement with customers and affirm our market readiness to meet customer demand for RSPO certified palm products.

Kensing is making great progress to only source RSPO-certified palm oil and palm products by the target year of 2025. While Kensing continues to target 2025, there are still challenges that remain. These include the availability of MB certified palm kernel and subsequent palm kernel oil for palm derivatives. Palm kernel certification is constrained by the corresponding certification of palm oil. If the palm fruit bunches are not certified, the palm kernel cannot be certified. In addition, there is insufficient demand for RSPO-certified palm oil products and market shortages of certified products. Kensing promotes RSPO CSPO in our engagement with customers and affirm our market readiness to meet customer demand for RSPO certified palm products.
Kensing is continuing to increase its purchases of RSPO MB products and has joined the Action for Sustainable Derivatives (ASD). Kensing has joined forces with other players to form a consolidated entity to create demand for RSPO certified materials and push the upstream players for more RSPO certification.
