As part of Lakeland Dairies wider business sustainability programme we will continue to provide updates and relevant information to our commercial team on the aims of the RSPO, the cultivation of CS palm oil and its use within our business and our products. In 2019 we extended the scope of our accreditation to include segregated and mass balance palm oils. We will aim to maintain our current certification level in the coming year. Lakeland Dairies have introduced segregated CSPO into a range of our powder products and as a consequence of this development, one of our customers has decided to change their product recipe to contain only segregated CSPO. In the coming year our technical and procurement teams will continue to engage with our customers and suppliers to identify further opportunities for the use of CSPO in our products. We will continue to promote the aims of RSPO within our sustainability engagement with the wider society and our stakeholders.
