Since March 2024, MB certified products have also been used for fats and oils used in 5 types of Morinaga biscuits. We have purchased B&C credits since March 2024, and combining MBs, we have achieved the status where 100% of the palm oil we procure is some kind of RSPO certified product.

In 1 year from April 2024 to March 2025, the proportion of MB certified oil is expected to increase to about 64%.
