1. Gap between EUDR and RSPO certified oils

Regulatory changes such as the EUDR did not help to improve buying decisions of RSPO certified oils as they are not meeting the sustainability requirements.

2. Price Premium and Demand

The higher price premium of RSPO certified palm oil makes it less affordable for some buyers, leading to decreased demand. This creates a disincentive for both producers and consumers as it hinders wider adoption of sustainable oils.

3. Imbalance between the supply and demand

The current market presents a challenge for the sustainability of the palm kernel oil industry. The imbalance between supply and demand of certified PKO products and very low demand from buyers in 2023 reduced the incentives for refiners to retain the long-term contracts with their kernel crushers. If this trend continues, it could have serious repercussions for the entire palm oil supply chain. Kernel crushers, facing high certification costs without a corresponding increase in demand for their sustainable product, may be forced to abandon the RSPO certification. This would be a major setback for sustainability efforts in the industry.
