#### Other

Since 2019, NUXE has been requesting a minimum RSPO Mass Balance commitment for any new palm-derived raw material entering our portfolio.

Since 2022 we are a member of Action for Sustainable Derivatives (ASD), a collaboration of brands and suppliers aimed to transform supply chains by increasing transparency, monitoring, and assessing risks while generating projects on the ground. The same year we also implemented our NDPE policy, available on our website\*.

Nuxe has committed that 100% of its palm-based ingredients will be at minimum Mass Balance RSPO\*\* certified by 2025. To meet this commitment, we continue to engage our suppliers to be certified.

To align with the latest European regulations that mandate the import of products free from deforestation, Nuxe is taking additional steps by employing a satellite tool\*\*\*. This initiative aims to ensure that the palm oil volumes used by our brand are not sourced from areas that have been deforested past the specified regulatory deadline.

Furthermore, in 2024, Nuxe plans to establish a grievance management system. This system will track grievances and facilitate engagement with our suppliers whenever a grievance implicates any participant within our supply chain.

#### Others

Nuxe mainly sources PKO-derived ingredients like most other personal care products companies. Today, there is a lack of availability of RSPO certified PKO-derived ingredients, specially in these years of tight supply ingredients. Moreover, the RSPO Mass Balance grade is not sufficient to reply to sustainable issues. We need more engagement in this grade such are more traceability from the mills to the plantation, respect of the Human Rights and a minimum certified volume. As a derivatives user, it is difficult to find Segregated RSPO derivatives due to a lack of availability for the personal care

As a derivatives user, it is difficult to find Segregated RSPO derivatives due to a lack of availability for the personal care products sector and when available the prices are too high.

The Regulation on Deforestation-free products will support those mentioned challenges and will bring new ones such as: - Aggravation of the scarcity of RSPO-Certified volumes

- Reassignment of production to less stringent countries about sustainability

- Price increases: transitioning to deforestation-free raw materials can lead to higher production costs.

- Relocation of palm transformation factories: To avoid customs issues, certain companies may move their palm

transformation factories out of Europe.

- Supplier sourcing changes: Some of our supplier may change their sourcing to be compliant.

- Due Diligence and traceability challenges
