The war in Ukraine severely reduced the availability of sunflower and rapeseed oil during the first part of 2022 and as a consequence, some of our companies temporarily reverted from these vegetable oils to RSPO SG palm oil, thus increasing the total volume of palm oil consumed in 2022.

But with the stabilization of the supply of these liquid oils in 2023 the volume and consumption of SG palm oil was reduced accordingly as some of the companies went back to using sunflower oil.
