We believe this demonstrates shared responsibility to drive demand for physical certified palm oil while avoiding unintended exclusion or disadvantaging of smallholders that could result as a consequence of strictly maintaining 100% physical certified palm oil. This year we have achieved 99% physical certified with the balance coming from ISH credits
