Currently we use 100% RSPO certified palm for selected brands. During 2023 the sales for brands containing certified palm has decreased resulting in an overall decrease in the usage of palm from 2845 tons to 2408 tons as well as a decrease in procurement of RSPO certified palm oi from 1928 to 1350 tons. On the otherhand our newly purchased brands from Pioneer under the Mamas, Big Jack and Todays have significantly increased from 741 to 945 tons. This resulted in a decrease of certified palm from 71% to 57%
