North America recently updated their Responsibly Sourced Palm Policy which will now cover items made in and brought to U.S. and Canada from elsewhere. In 2021, Rich's USC & UK mandated that all crude and refined palm and palm kernel oil used in Rich's products must be certified by the Roundtable on Sustainable Palm Oil (RSPO) under mass balance (MB) or segregated (SG) standards.

By January 1, 2025, Rich's to source only deforestation-free and conversion-free (DCF) palm oil. This commitment encompasses all types of palm oil utilized in Rich's products, spanning crude palm oil, refined palm oil, palm kernel oil, fractions, expellers, and derivatives, regardless of their origin.
