The bulk of our production comprises 50% Palm Kernel Expellers (Certified and Non-Certified). Uptake of CSPKE is Zero metric ton due to no buying interest in the physical market. This resulted in the overall low 13.82% as the computation is CSPKO quantity against the overall total CSPKO, CPKO, CSPKE and PKE. The uptake as a single product is 30.42% which is slightly lower than the 2022 of 33.73%. Some of our traditional suppliers have already set up their own palm kernel crushing plants and this resulted in very limited mills here selling their Certified Palm Kernels. As our ability to increase the uptake of CSPKO is limited by the number of RSPO Certified Plantations and smallholders. The number of RSPO Certified Crushers in the our market place competing against each other for the limited amount of CSPK production has capped our ability to increase in our uptake numbers.
