Our use of palm oil derivatives has decreased slightly in 2023 from 840 tonnes in 2022 to 643 tonnes in 2024. Also our use of palm kernel oil derivatives has dropped from 55 tonnes in 2022 to 21 tonnes in 2023. This is most likely due to the increased costs of raw materials across the board in 2023. The increased price for these materials has driven consumer demand down.
