

For the 2023 reporting year we maintained our 100% RSPO certified oil achievement and are now working to move suppliers through a continuous improvement process: Credits; Mass Balance; Segregated and IP. Tesco Group has already achieved 85% RSPO Segregated palm oil supply and 14% RSPO mass balance palm oil supply, with the remainder covered by ISPO and ISPKO Credits (1%).
