We have approved Sime Darby Oils Liverpool as a supplier of Segregated Refined Palm Oil. In 2023 we targeted to get 15% of our Refined Palm Oil requirements from them. and over-achieved on this target by 10% (25% of our refined palm oil in 2023 was segregated).

Our target for 2024 is to procure 35% of our refined palm oil as segregated from Sime Darby Oils.
