We continue to inform our new customers and all our suppliers of our RSPO strategy. 4. Some ingredients contain small palm volumes allocated on numerous suppliers that rely on a long and complex supply chain. 5. At this stage, we have no direct contact with the independent smallholders. 6. At the specific request of certain customers, we may question our suppliers on the scrupulous respect of the prescriptions of the RSPO P&C with certain plantations.
