Our main challenge is the market of derivatives. First the lack of traceability, but as well the availability of at least MB-certification. Many manufacturers in the derivative market buy certified palm (kernel) oil, but they are still not (willing) to get RSPO-certification by themselves, so that their end-products are not certified by RSPO. But in fact, the used palm oil for the processing of their derivatives was certified in the prior supply chain.

In the meantime, we only have 0.10% of our total purchased volume of derivatives that are only B&C certified.
