In the coming year, our company plans to promote the use of certified sustainable palm oil (CSPO) by actively engaging with our business partners and brand owners. We will focus on educating our clients about the benefits of RSPO certification and how it supports their sustainability goals. This includes sharing relevant materials and updates, as well as offering guidance on sourcing RSPO-certified palm oil derivatives. In all new product development and quotations, we will include the option to use CSPO to raise awareness and encourage its adoption. Internally, we plan to train our procurement and sales teams to better support our clients in understanding and transitioning to sustainable palm oil. We will also work closely with our suppliers to improve the availability and affordability of RSPO-certified ingredients. Additionally, we aim to support clients who choose CSPO by offering promotional or marketing assistance for their certified product ranges.

The use of certified sustainable palm (kernel) oil (CSP(K)O) involves additional costs, which must be incorporated into relatively low-cost and basic products such as soap bars. Encouraging customers to participate and share the cost premiums is a significant challenge and a real barrier to increasing the share of CSP(K)O in our production. Some customers and markets are not yet fully aware of the RSPO or the importance of certified sustainable sourcing. At the same time, palm oil often suffers from negative public perception, and as a result, some business clients are sceptical about RSPO and its credibility. Additionally, upcoming regulatory changes such as the EU Deforestation Regulation (EUDR) pose another significant challenge. While RSPO provides valuable assurance on sustainability and traceability, it is currently not recognized under the EUDR framework, which creates confusion among stakeholders and increases the complexity of compliance. These factors combined make it difficult to convince customers to adopt CSP(K)O in their products and accept the associated cost increase. To address these challenges, we continue to raise awareness among our partners about the benefits and credibility of RSPO certification, while monitoring regulatory developments and exploring ways to improve both cost efficiency and traceability in our supply chains.
