In the reporting year, Belina used a total of 111 metric tons of palm oil and related products, out of which 90 metric tons (81.08%) were certified according to RSPO standards.

We did not purchase or use RSPO Credits to cover the remaining volume. The gap in certified uptake was solely due to temporary disruptions in the supply chain, such as limited availability of certified products and logistical challenges beyond our control. These factors affected our ability to reach 100% certified supply despite our ongoing commitment to sustainable sourcing.

Belina remains committed to increasing the share of certified palm oil in our operations and is working with suppliers to improve access and planning for certified volumes in future reporting periods.
