Edgewell joined the RSPO in 2022 with a strategic goal to source 100% certified palm oil for our products by 2030. This goal was achieved by using certified supplier materials and purchasing credits to cover non-certified palm oil. Although Edgewell does not directly purchase palm oil, we are committed to obtaining 100% certified palm oil ingredients through our ingredient suppliers and contract manufacturers. We have worked closely with suppliers who previously did not use certified sources, requiring them to develop transition plans to certified RSPO ingredients. We are seeing an increase in certified usage and will continue this effort until we achieve 100% certified sourcing.

Edgewell launched its Palm Policy in 2024, distributing it to ingredient suppliers and TPMs that use palm-derived ingredients, setting the expectation of moving to 100% certified sourcing and completing due diligence procedures as needed. Edgewell is committed to sourcing 100% of the palm oil used in our products from certified sources, with Mass Balance as a minimum requirement. We employ a multifaceted approach to meet this objective, including the purchase of RSPO certified palm oil and palm oil derivatives, the creation of robust sourcing practices, and the dissemination of expectations within our Supplier Code of Conduct. We will achieve this through the following short-term steps:

1. Work on converting the remaining uncertified palm usage to certified palm usage without the need to purchase credits.
2. Increase traceability and transparency among our suppliers to better identify potential risks and mitigate them quickly to avoid issues.
3. Enhance education and awareness about sustainable palm oil and its significance for Edgewell, as well as the communities and countries affected. We will engage both internal and external stakeholders in this effort.
