Formulation Source (DBA Chemical Source) is an RSPO-licensed distributor and trader of palm oil-derived products, including glycerin and other oleochemicals. We hold both RSPO trader and distributor licenses, and we purchase these materials from overseas suppliers, primarily in China, Malaysia, and South Korea. We distribute them to customers in the personal care and industrial sectors.

Our operations do not include any direct manufacturing, refining, or processing of palm oil or palm kernel oil. We operate as a distributor and trader, managing both physical stock stored in third-party logistics (3PL) facilities and direct shipments from suppliers to customers.

We ensure that our RSPO-certified products are properly segregated and documented according to RSPO requirements. Our 3PL partners store materials but do not engage in any processing of palm oil materials.

Summary of operations:

Certified operations: All distribution and trading activities conducted by Formulation Source (DBA Chemical Source) under our RSPO trader and distributor licenses.

Uncertified operations: We may occasionally handle non-certified palm oil derivatives (e.g., non-certified glycerin) sourced from suppliers to meet customer requirements.

During the reporting year, our company maintained a strong commitment to RSPO-certified materials by consistently sourcing and trading only RSPO Mass Balance (MB) glycerin. We actively promoted certified products to our customers, highlighting our support for sustainable palm oil supply chains. As a result, we did not have any demand for non-RSPO material during this period. This reflects both our evolving operational focus on sustainability and our customers' increased awareness and preference for RSPO-certified products.
