At our facility, we manufacture solid soap bars and handle the packaging of liquid cosmetics that are blended by third-party companies using formulations developed by GFL. Until 2021, we only managed certified palm oil and palm kernel oil for our solid soap production. Therefore, the data reported in our previous ACOP submissions referred exclusively to the palm-based ingredients used in soap bars.

Starting in 2022, we began incorporating certified palm oil and palm kernel oil also into our liquid formulations. As a result, the figures reported in the current ACOP now include palm oil derivatives and fractions used in liquid products such as shampoo, body wash, liquid soap, conditioner, and body lotion.

The products we manufacture fall into two main categories:

*Private label cosmetics for cosmetic brands or large-scale retail companies, which have increasingly begun to require RSPO-certified palm oil in their products.

*Own-brand and labeled products for the hospitality sector, a highly price-sensitive market with limited demand for RSPO-certified ingredients.

In the case of our own-brand products, it's important to note that the hospitality market is extremely price-sensitive and currently shows low demand for RSPO-certified solutions.
