Sourcing RSPO-certified palm derivatives is a unique challenge, made more complex by the fact that we partner with a third party manufacturer. We are doing our best, but we are a small company that mostly uses palm derivatives to formulate our candle wax, and we have not located a source for identity preserved or segregated derivatives. When and if we do, affordability will be a major factor.

We will also continue to contribute to the Orangutan Land Trust and Borneo Nature Foundation and CAN Borneo and the work they do in advancing sustainable palm and other community outreach and environmental initiatives around palm, including but not limited to forest restoration and endangered wildlife rescue/rehab/release.
