In addition to our uptake of 100% certified palm products we bought 3 IS CPO credits and 69 IS CPKO credits. As a member of the German forum for sustainable palm oil we are obliged to use only segregated palm kernel oil for the markets in Germany, Austria & Switzerland. For using 69t Mass Balance palm kerneloil we bought small holder certificates. Also for 3 tons of mass Balance fractions we bought the corresponding amount of 3 IS palm certificates.
