We currently source only RSPO Mass Balance (MB) certified soap noodles for our production of bar soaps. All of our palm-based inputs are covered under this certification model, and we do not use RSPO Credits or other certification models at this time.

There have been no significant changes in our certified uptake, as we maintain a consistent sourcing strategy with MB-certified suppliers. Our supply chain remains stable, and we continuously monitor supplier compliance to ensure alignment with RSPO standards.

At this stage, we do not have direct programs with independent smallholders, but we support the RSPO's broader efforts through our commitment to sourcing certified materials.
