Due to huge price increases and difficulty of supply for cocoa products many customer are moving to compound chocolate (containing palm oil) in lieu of real chocolate (using no palm product). This has increased our usage of palm kernel oil. Our stock holding position is good not requiring RSPO credits as this stage. Our business in looking at possibly purchasing RSPO credits to support independent smallholders.
