The majority of sales are made direct to pharmacies, retailers or consumers in Europe and North America through several entities: Karo Healthcare (AB; UK Ltd.; B.V.; Gmbh; S.L.; ApS; Inc), Karo Pharma (AS; AG), Trimb Healthcare (AB; UAB), Sylphar NV, Alpha Foods BV, Nutravita Ltd, CCS Skincare brands AB, ProTeeth Whitening Ltd. Sales outside these core markets are managed by our International Trade Business department and distributed through local partners around the world.

Our products are manufactured by contract manufacturers (CMOs), which means that Karo does not have direct control over the sourcing of raw materials and ingredients. To assess our palm oil footprint, we consolidated the ingredient lists across our full product portfolio (e.g. INCI for cosmetics) and calculated the total weight sold for each ingredient. Through this analysis, we identified a number of ingredients that are palm oil-derived, amounting to an estimated 795 tonnes. While we know these ingredients are derived from palm oil, we have not determined whether they come specifically from palm oil or palm kernel oil.

We covered the full volume through the purchase of RSPO book and claim credits (CSPOs), applying a conservative approach. It is likely that some of these ingredients were already sourced from RSPO certified sources, or that some CMOs or upstream suppliers have independently purchased book and claim credits.
